CONDITIONS OF APPROVAL

1. The manufacturer is to maintain following at all times:
 - a. Valid effective quality system complying with the most current version of ISO 9000 series
 - b. Valid FSSAI licence
 - c. Hygienic practices as per Annex B of IS 14543:2016 as amended
 - d. Handling of polyethylene flexible film meant for packing of packaged drinking water in pouches as per Annex E of IS 14543:2016 as amended
2. Expiry date of product is 5 years after the date of production.
3. The predicted shelf life of the product is to be established by validating through laboratory testing for accelerated growth on identified samples and the record of tests is to be maintained for review during annual surveillance audit of the works. Deviation if any noticed is to be intimated for reassessment of product shelf life. Further, record of stabilization study of the product is to be maintained for reference.
4. Sampling plan for package drinking water is to be as per Annex F of IS 14543:2016 as amended. Records of the production tests in compliance with SOLAS Chapter III/5, IMO Resolution MSC.81 (70) Part 2 Para 1.2 are to be maintained.
5. Product will require re-approval under following circumstances:
 - a. Any changes to the approved design parameters or construction or M.S. Life Saving Appliances Rules and LSA Code
 - b. Any changes in the location /address of the manufacturer as stipulated in the certificate without informing IRS in writing
 - c. Any alteration being made to the manufacturing facilities and product procedure.
 - d. Any changes to the source of raw water collection.
6. Water sachet is to be clearly marked with approval information as per LSA code regulations I/1.2.2.9 and each individual water sachet to be clearly marked with:
 - a. Name and address of Manufacturer
 - b. Certificate number and date
 - c. Designation of product/Brand name/Trade name
 - d. Quantity of supply
 - e. Batch No/Lot number
 - f. Date of Manufacture and expiry
 - g. Instructions for use
 - h. Recommended daily consumption per person
 - i. Approval Authority [IRS on behalf of Indian Flag]
